- Review of the FY23 Budget
 - Reagan Hage, NEI, reviewed the main changes to the draft budget of FY 23.
 - 1. Increase in funding for SPED
 - 2. Addition of a facility grant to increase federal grants amount
 - 3. Decreased cost of compensation
 - Telephone and internet have increased. Internet monthly amount seems high, will look into these costs. Electricity has decreased
 - 5. Maintenance and Cleaning supplies have decreased
 - Building Repairs and Maintenance have increased to be more in line with the updated forecast
 - 7. Outside Staff Development has decreased
 - 8. Contracted SPED has increased
 - Contracted Custodial Services is high and needs to be reduced
 - Looking into the Computer Software/Instructional Software categories to make sure some software is not listed in both categories
 - Board Members need and explanation for variances and reclassifications
